

WEBSITE PRIVACY POLICY

My Body by Design LLC is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the My Body by Design LLC Web site and governs data collection and usage. By using the My Body by Design LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

My Body by Design LLC collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. My Body by Design LLC also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by My Body by Design LLC. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by My Body by Design LLC for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the My Body by Design LLC Web site.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through My Body by Design LLC public message boards, this information may be collected and used by others. Note: My Body by Design LLC does not read any of your private online communications.

Use of your Personal Information

My Body by Design LLC collects and uses your personal information to operate the My Body by Design LLC Web site and deliver the services you have requested. My Body by Design LLC also uses your personally identifiable information to inform you of other products or services available from My Body by Design LLC and its affiliates. My Body by Design LLC may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

My Body by Design LLC does not sell, rent or lease its customer lists to third parties.

My Body by Design LLC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, My Body by Design LLC may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to My Body by Design LLC, and they are required to maintain the confidentiality of your information.

My Body by Design LLC does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

My Body by Design LLC keeps track of the Web sites and pages our customers visit within My Body by Design LLC, in order to determine what My Body by Design LLC services are the most popular. This data is used to deliver customized content and advertising within My Body by Design LLC to customers whose behavior indicates that they are interested in a particular subject area.

My Body by Design LLC Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on My Body by Design LLC or the site; (b) protect and defend the rights or property of My Body by Design LLC; and, (c) act under exigent circumstances to protect the personal safety of users of My Body by Design LLC, or the public.

Use of Cookies

The My Body by Design LLC Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize My Body by Design LLC pages, or register with My Body by Design LLC site or services, a cookie helps My Body by Design LLC to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
